### **Erich Schuttauf-Executive Director**

The Executive Director highlighted a few items from his report, including some new charter clubs, Bare RV and Rocky Mountain Naturists. A few Government Affairs issues of note were firstly the Arkansas case with a mother and her son where the judge recused himself from hearing the case further for unknown reasons. Secondly, out of Ontario, Canada with a mother and her daughter in a custody case. Lastly, Al Gilewicz with the AANR Education Foundation was interviewed about the Buck Creek Club in South Carolina and the 5K Creek Streak, that eventually garnered the attention of late-night host Stephen Colbert who mentioned it on his show which resulted in a great boost in registrations. Finally, a mention of a case stemming from citations Canaveral National Seashore and AANR has stepped up to help the parent in that case in federal court.

### **Linda Weber- President**

Linda Weber read through her submitted report.

### **Patty Faber- Vice President**

Patty talked about going through the checklist of to – do items on her action list. She will be attending a few conventions on behalf of the AANR Executive Board.

### **Mitch London-Secretary/Treasurer**

No report.

### **Bob Dixon- Internal Administration**

Bob gave a brief update on the current Internal Administration investigations, one of which was delivered to the board in executive session, the other is still on going.

### **Tim Mullins- Government Affairs**

Tim said that there was nothing pressing or to expound upon what Erich had already mentioned.

The Executive Director expressed thanks to all the GAT members.

### **Patty Faber- Vice President**

Patty took a minute to acknowledge the dignitaries in attendance of the meeting.

### **Evan Nix- Public Relations**

Evan gave a summary of his report and highlighted some of the projects they have such as the “My Nude Story” campaign, and the Visible Altruism campaign.

### **Margie Cantlon-Conventions and Facilities**

Margie mentioned the upcoming convention dates and location, and an article for a future Bulletin about the convention.

### **Cyndi Tendick- Strategic Planning**

Cyndi’s report was delayed but will be included after the meeting. She is making some comparisons with other organizations like ours that we might glean some insight as to what we might change in our Strategic Plan. AANR turns out to be unique in its organization and therefore difficult to compare to something else.

### **Kathy Watzel-Finance**

Kathy had her report as well as two separate financial reports. One was just the financials updates on what has occurred since the last meeting and the other statement was a financial statement from the auditor. She gave information about the auto pay that AANR wants to implement with the hopes of retaining members who may forget to renew. The cost would be \$12,000 to set it up, and she has a breakdown of the costs that make up the \$12,000 if any needs it. There is an urgency to get this in place because it will take a year before we see the benefits when people renew. This is for direct members now and will be expanded to include all club members. There is also a \$4,000 text messaging feature that would allow AANR to text members at a certain time to

be a reminder for upcoming or recently passed membership renewals. Statistics show people respond more frequently to texts than they do to email or postal mail and it is much cheaper to send out. People will have the option to 'opt out' of text messaging as is required by law. Texts can be used to renew members, and it could also be used to send out messaging to all members, or members of a particular region as needed by a Trustee or President to get word to their members. The AANR office would benefit by not having to send letters or emails as this could be set up to send automatically near a member's renewal date. It would also be able to notify the person if their credit card is out of date and they could update it with a new one. The system will also notify the office if there is an unsuccessful attempt to change the credit card, and they can contact the person.

The Dues Modernization Committee chair mentioned that analysis shows that cumbersome systems is a reason why some don't become a 100% club and if this were implemented it would really be listening to the membership. Another mentioned it would be financially smart and practically smart since we all live on our cell phones these days.

Bob Dixon praised the authors of the analysis that went out in April with the hopes that this type of reporting would be a regular occurrence in the future but also wished for more information on the reporting on the balance sheet.

Bob expressed a wish for a business case to have been presented. He asked for more concrete numbers of what the income would be, but it was said that concrete numbers are difficult to come up with as it won't be realized for one year after implementation, but some estimations were presented to give an example.

### **George Oberle-Membership Marketing.**

The Membership/Marketing editorial calendar looks pretty active. June will have two events, National Nude Hiking Day which there will be articles, press releases and social media content posted. Then there is Nude Recreation Week starting June 23 this year, which also includes Skinny Dip Day. The hope

is to send out a variety of information all at the same time rather than bit by bit, so that it is seen over many platforms at the same time.

It was noted that people have started consuming the 'How to Start a Non-Landed Club and How to Manage one.

July will have Women in Naturism events, and on the 29<sup>th</sup> promotion for the next convention will start.

Another big project is the AANR Ambassador Program where members can apply to be an AANR Ambassador. A resource handbook is being created to help new Ambassadors work at the club level, or the beach level and at the nature level to answer questions about AANR and naturism in general.

A mention of some articles on the Website that have been getting a bunch of page views has been the 'Celebrate Home Nudists' article which 1600 people consumed. Also, the recent Combatting Loneliness as well as the Women in Nude Recreation pages were also among the top page views and most commented upon. The website had almost 80,000 pageviews and 49,000 unique people that visited the site in May of which 20,000 were from organic searches from Google search.

Mitch London- Asked for the report to be sent to him to be included.

### **Kane Stanton- Young Adult & Diversity Advisory Council (YADAC)**

Kane read through his report and noted one project they are working on is working with Green Valley Nudist Camp to try and find out why they don't get many younger members. YADAC worked with them and did analyses and held conversations to offer ideas as to how to garner new younger members.

### **Joe Rives- Membership Dues Modernization**

The decline in member loss is being seen in real numbers and we are starting to see stabilization. It was expressed that the one fee per transaction should be communicated to members, so they can share dual direct membership to two-year renewal information with current and prospective members. Legacy

fees have also been waived for direct members. They still need to do the paperwork with the office, however.

Joe also said another benefit to the auto renewal is reducing processing times of memberships. He said he will also present full sets of results from club surveys at the Oklahoma convention.

### **Patty Faber- Mentorship Program**

Patty said in most if not all regions there is a lack of bodies to fill seats on the various boards. It is not enough to just ask someone to run, but you need to invite them personally to attend and then be there to answer questions and engage with them. You can't also just leave them once they do join, you have to help them, mentor them and work with them so they feel they have someone to answer their questions. When you mentor someone properly you can have a person willing and able to work on the board of their region or AANR for a long time. She mentioned she and Bob have been on board with AANR for over 20 years and more on their regional board.

### **Mike Parker- Glen Miller Loan**

There are 8 clubs right now that have active loans with all loans expected to be paid back in a couple of payment cycles. It was stressed to let clubs know that this interest free loan program is available to member clubs.

### **Andee Rogers- WINR**

The I'mPerfect Tour is going to Canada this year. The Women One Word (WOW) calendar is going to end with the 2026 calendar unless the new WINR chair takes that on as Andee is stepping down at the end of her term to work regionally. A check to pay back the loan from the AANR Education Foundation for the calendar has been sent and another is forthcoming. Andee mentioned a couple of clubs have recently started their own WINR group.

Joe gave an overview of the report submitted by the Regional Presidents where there were five recommendations that they hope the board will read and consider.

### **Linda Weber- Club Terminations**

Linda mentioned there were 16 clubs across 5 regions that did not meet the AANR requisites to being charter members, and the process of revoking charters has been started.

### **BG Parkes- Wreaths Across America**

BG first asked if there were any questions about the letter drafted to alert members to an emerging situation in Florida with respect to lawmakers' attention to nudism with family nudism in particular. It also sought to raise funds for the effort. No questions were raised.

BG talked about the history of the Wreath Across America program and the controversy about the company that makes the wreaths. AANR will again participate in the program this year and for each wreath bought at \$17 under the AANR name, AANR will get \$5 which will be earmarked for the Government Affairs fund. The \$17 is tax deductible. The wreaths will be placed December 13 at over 4900 locations and 50 states and at sea. BG will be writing an article for the Bulletin to give out the details.

Mike Parker mentioned his region had set up a fund where part of their income from AANR dues goes into the legislation fund which caps at \$60,000. If some of it gets used, then the money from dues goes back in until it hits the cap.

### **Motion #5**

I move to allocate \$12,000 to implement auto pay.

There has been a disconnect as far as what we consider ourselves when we talk about what our organization is. We are a not-for-profit status which is different from a non-profit status and let me read this out and I'll be sure and put this in the minutes.

AANR is a not-for-profit organization officially recognized that the 501(c)(7) under the US IRS code and what that means is that not-for-profit mission meaning AANR does not exist to generate profit for individuals. Instead, its core purpose is to promote and protect the privileges of nudists. Encourage body acceptance and to foster a strong values-based community centered around nude recreation. The 501(c)(7) classification is the IRS designation for specific to social and recreational clubs. AANR is primarily supported by membership dues and revenue derived by members. Which it uses to fund its programs, advocacy and member services. It is not a charitable organization. Unlike 501(c)(3), charities, AANR is not classified as a charitable organization and as such contributions or dues paid to AANR are not tax deductible for donors or members.

So, when you explain it or write it out, please use the term not-for-profit.
